





Relative Intensity Vs. Wavelength










CIRCUIT DESIGN NOTES


- 1.Protective current—limiting resistors may be necessary to operate the Displays.
- 2.LEDs mounted in parallel should each be placed in series with its own current—limiting resistor.




- 1.We recommend the reflow temperature 245°C(+/-5°C).The maximum soldering temperature should be limited to 260°C.
- 2.Don't cause stress to the epoxy resin while it is exposed to high temperature.
 3.Number of reflow process shall be 2 times or less.


Recommended Soldering Pattern (Units: mm; Tolerance: ± 0.15)

Reel Dimension




Tape Specifications (Units: mm)
