

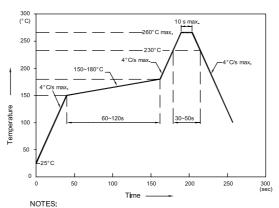


Reflow soldering is recommended and the soldering profile is shown below. Other soldering methods are not recommended as they might cause damage to the product.

Reflow Soldering Profile For Lead-free SMT Process.




- We recommend the reflow temperature 245°C(+/-5°C). The maximum soldering temperature should be limited to 260°C.

 3.Number of reflow process shall be 2 times or less.


Recommended Soldering Pattern (Units: mm; Tolerance: ± 0.1)

Reel Dimension







